AN ORDINANCE CLOSING AN ALLEY IN THE  
B.F. GOLDEN ADDITION  
OF THE VILLAGE OF ST. PARIS, OH, CHAMPAIGN COUNTY

THEREFORE, be it ordained by the Council of the Village of St. Paris, OH, Champaign County:

SECTION 1: To close the following 16ft alley of the B.F. Golden Addition as described:

1. The alley is bounded on the North by Oak Alley (Street) of the B.F. Golden Addition.
2. The alley is bounded on the South by the former Railroad.
3. The alley is bounded on the West by Lot # 39 of the B.F. Golden Addition.
4. The alley is bounded on the East by Lot # 1 of the B.F. Golden Addition.

SECTION 2: The retention of an easement for public utilities is reserved to the Village of St. Paris.

SECTION 3: This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

SECTION 4: This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the peace, health, and safety of the people of Saint Paris so as to conform Village Ordinance to recent changes in state law, and shall take effect at the earliest date provided by law.

THEREFORE, be it resolved by the Council of the Village of St. Paris, OH, Champaign County upon the affirmative vote of all elected members of said Council, that Council adopt the foregoing Ordinance.
