To accept the Petition for annexation of Duane Miller, Agent for the Petitioner and member of the Board of Education of the Graham Local School District, of certain territory containing 110.531 acres, more or less, in Johnson Township, Champaign County, Ohio to the Village of St. Paris, Champaign County Ohio.

WHEREAS, a petition for the annexation of 110.531 acres, more or less, in Johnson Township, Champaign County, Ohio was duly filed with the Champaign County Commissioners, Champaign County, Ohio on the 28<sup>th</sup> day of April, 2009 by Duane Miller, agent for petitioners, Graham Local School District, Nadane McCormick, Kenneth J. Dyer, Harold E. Copley's, and Marsha A. Copley; and

WHEREAS, on July 16, 2009 the Board of County Commissioners of Champaign County, Ohio approved the annexation of the territory to the Village of St. Paris, Ohio; and

WHEREAS, pursuant to Section 709.07(C) of the Ohio Revised Code, the Village Council of the Village of St. Paris has determined to accept the Petition for annexation;

NOW, THEREFORE, be it ordained by the Village Council of the Village of St. Paris, Ohio:

Section 1. That the proposed annexation of 110.531 acres in Johnson Township, Champaign County, Ohio to the Village of St. Paris as applied for in the Petition of Duane Miller, Agent for Petitioners, Graham Local School District, Nadane McCormick, Kenneth J. Dyer, Harold E. Copley, Sr. and Marsha A. Copley which Petition as approved for annexation to the Village of St. Paris, Ohio by the Board of County Commissioners on July 16, 2009 is hereby accepted. The territory is described on the attached Exhibit A.

Section 2. The certified transcript of the proceedings for said annexation of 110.531 acres in Johnson Township, Champaign County, Ohio to the Village of St. Paris, Ohio with an accurate map of the territory together with the Petition for its annexation, and other papers relating to the proceedings, hereto are on file with the Village Clerk.

Section 2. That the Village Clerk is hereby authorized and directed to make three (3) copies of this Ordinance to each of which shall be attached a copy of the map relating to the annexation proceeding, a copy of the transcript of proceedings of the Board of County Commissioners relating thereto and a certificate as to the correctness thereof. The Village Clerk shall then forthwith deliver one copy to the County Auditor, one copy to the County Recorder and one copy to the Secretary of State and shall file notice of this annexation with the Board of Elections within thirty (30) days after it becomes effective, and the Clerk shall do all the things required by law.

Section 3. In accordance with Ohio law the zoning regulations in effect within the above-described annexation area on the date the annexation becomes effective, shall be administered and enforced by the Village until an amendment to the Village Zoning Ordinance is adopted establishing a zoning classification(s) under said zoning Ordinance.

Section 4. That this Ordinance shall take effect and be in force from and after thirty (30) days from the date of its passage.
