ORDINANCE # 887

AN ORDINANCE FOR RESTRICTED PARKING IN FRONT OF THE GRAHAM LOCAL SCHOOL BOARD OFFICE LOCATED AT 370 EAST MAIN STREET, IN THE VILLAGE OF ST. PARIS, OHIO

It is the desire of the Village Council to restrict on street parking on the north side of the street at 370 East Main Street, St. Paris, Ohio 43072 in order to allow for the flow of traffic on school days and to protect the health safety and welfare of the general public within the Village of St. Paris.

THEREFORE BE IT ORDAINED by the Council of the Village of St. Paris, Ohio, Champaign County:

Section 1: On any day when Graham Schools are in session, there shall be no parking between the hours of 6:00 a.m. and 5:00 p.m. Monday through Friday.

Section 2: The no parking shall apply to the 370 feet of public roadway on the North side of Main Street located in front of the Graham Local School Board Office at 370 East Main Street, St. Paris, Ohio.

Section 3: There are railroad tracks that cross Main Street and which are located East of the Graham School Board Office. The starting point for the restricted parking shall be on the North Side of Main Street 750 feet from the center of the railroad tracks.

Section 4: The ending point for the restricted parking shall be 370 feet West of the starting point as identified in Section 3 of this Ordinance.

Section 5: The area between the starting point, as identified in Section 3, and the ending point, as identified in Section 4, shall be the area of the public roadway wherein parking is hereby restricted in accordance with this ordinance.

Section 6: Any person who violates this Ordinance shall be guilty of a parking violation, which is a minor misdemeanor.

THEREFORE, be it ordained by the Council of the Village of St. Paris, OH, Champaign County upon the affirmative vote of all elected members of said Council, that Council adopt the foregoing Ordinance.
