AN ORDINANCE CLOSING AN ALLEY IN THE  
D.W. WHITE 2ND ADDITION  
OF THE VILLAGE OF ST. PARIS, OH, CHAMPAIGN COUNTY

THEREFORE, be it ordained by the Council of the Village of St. Paris, OH, Champaign County:

SECTION 1: To close the following 12 foot alley as described:

1. The alley is bounded on the North by State Route 36.
2. The alley is bounded on the South by an Alley of the D.W. White second addition.
3. The alley is bounded on the West by Lot 200 of the D.W. White second addition.
4. The alley is bounded on the East by Lot 199 of the D.W. White addition.

SECTION 2: The retention of an easement for public utilities is reserved to the Village of St. Paris.

SECTION 3: This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

THEREFORE, be it ordained by the Council of the Village of St. Paris, OH, Champaign County upon the affirmative vote of all elected members of said Council, that Council adopt the foregoing Ordinance.
