AN ORDINANCE CLOSING AN ALLEY IN THE

SECTION 1: To close the following 10 foot alley as described:

1. The alley is bounded on the North by an Alley and Lot 7 of the Original Plat. *part of lot 6 and lot 8*
2. The alley is bounded on the South by Lots 9 and 10 of the Original Plat. *portion of*
3. The alley is bounded on the West by an Alley of the Original Plat. *portion of*
4. The alley is bounded on the East by Lot 145 of the J. S. Leedom Addition.

SECTION 2: The retention of an easement for public utilities is reserved to the Village of St. Paris.

SECTION 3: This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

THEREFORE, be it resolved by the Council of the Village of St. Paris, OH, Champaign County upon the affirmative vote of all elected members of said Council, that Council adopt the foregoing Ordinance.
