AN ORDINANCE TO ABOLISH THE SEWER ASSESSMENT ORDINANCE # 501, IN ITS ENTIRETY.

WHEREAS, the Council of the Village of St. Paris had previously passed Ordinance 501 to implement phases of study, design, construction and other costs associated with an additional sewage plant for the benefit of the Village.

WHEREAS, the above mentioned phases have been implemented and funds have continued to be collected for the capital improvement of the sewage treatment facility.

WHEREAS, at the present time there are sufficient funds available to meet the short term demands of the sewage plant for the Village. However, Council recognizes that a capital improvement fund is needed for the sewage treatment facility in order to address existing and future capital improvement projects or any other sewer expense deemed necessary with the prior approval of the Village of St. Paris Council;

NOW THEREFORE, be it ordained by the Council of the Village of St. Paris, Ohio as follows:

Section 1. All funds that are now in the sewer assessment fund shall stay in that fund and may only be used for operating and maintaining the sewage treatment plant or for capital improvement costs, interest, debt, principle payments or other appropriate charges related to the sewage treatment plant as directed by Council with prior expenditure approval of Council.

Section 2. The sewage assessments currently being made pursuant to Ordinance 501 shall hereby be terminated. The September 2012 sewage assessment shall be the last month that an assessment is issued pursuant to Ordinance 501. Council understands that the Village will issue a billing statement in October 2012 which will reflect the September Assessment.

Section 3. Any funds already collected and assessed shall remain in the sewage assessment fund and shall be used in a manner as indicated in Section 1 of this Ordinance.

This ordinance shall take effect and be in force as indicated herein.

THEREFORE, be it ordained by the Council of the Village of St. Paris, County of Champaign and State of Ohio upon affirmative vote of all elected members of said Council, that the Council of the Village of St. Paris, County of Champaign, State of Ohio adopts the foregoing corrective Ordinance.

This ordinance passed and adopted by the Council of the Village of St. Paris, OH, Champaign County, this 17th day of September, 2012.
